

IIFM Scholarship Call for MASTER'S PROGRAMS APPLICATIONS - Academic Year 2026/2027

1. Purpose

The Italian Institute of Fashion Management announces the opening of the application process for partial scholarships for the academic year 2026/2027. Scholarships are available for candidates enrolled in the Master's programs offered by the Institute.

Each scholarship will cover 50% of the total tuition fee, amounting to €10,500.

2. Eligibility Criteria

Scholarships are open to:

- Candidates already admitted to one of IIFM's Master's programs for the academic year 2026/2027.
- Both Italian-resident and non-resident students.

Grants will be awarded based on:

- Academic merit and motivation
- **Financial need**, evaluated through specific documentation attesting the financial and asset condition of the student's household.

3. Number and Value of Scholarships

Each partial scholarship covers 50% of the tuition fee, equivalent to a total value of €10,500.

The number of scholarships available is determined annually by the Board of Directors, in accordance with the social mission and objectives of the Institute.

In addition to general scholarships, dedicated scholarships may be allocated to specific categories of applicants, such as citizens of certain countries or candidates meeting particular eligibility requirements.

4. Application Procedure

4.1. Required Documents

A. For Italian-Resident Students

Applicants must submit:

 A valid ISEE certificate (Indicatore della Situazione Economica Equivalente), referring to the most recent tax year available.



B. For Non-Italian-Resident Students

The following documents must be submitted:

- In English or Italian or original language, accompanied by an official translation into Italian or English
- Both original and translated versions must be legalized and stamped by the relevant Italian authority abroad (e.g., Italian Embassy or Consulate), or by an official translator.

Required documents:

1. Certificate of household composition

- Listing all family members residing at the same permanent address as the applicant.

2. Income certification

– Declaration of gross annual income for the latest calendar year, for each employed family member, issued by their employer.

3. Movable assets documentation (as of December 31 of the latest year available)

- Bank account statements, savings accounts, investments, shares, dividends, or similar financial assets for each household member.
- If no assets are held, an official declaration of non-possession must be submitted.

4. Real estate assets documentation

– If any family member owns property: document stating property size (in m²) and any mortgage details, including unpaid balances.

5. Submission Details

Applications must be submitted exclusively through the official Application Form for the chosen Master's program.

Candidates must upload all required scholarship documents in the designated "Scholarship Application" section of the form. Incomplete or late submissions will not be considered.

6. Evaluation and Selection

Applications will be evaluated by the IIFM Scholarship Committee on the basis of:

- Academic qualifications and motivation
- Financial documentation submitted

There will be four evaluation sessions during the application cycle:

- June 30, 2025
- August 30, 2025
- September 30, 2025
- November 30, 2025

Applicants will be notified of the outcome of their scholarship application shortly after each evaluation round.

In cases where multiple applicants achieve the same merit score, priority in the ranking will be given to candidates with greater financial need, as determined by the assessment of submitted documentation.



Should a selected applicant withdraw or decline the scholarship, the benefit will be automatically reallocated to the next eligible candidate on the ranking list, based on the established evaluation criteria.

Scholarships will be formally awarded upon completion of enrollment and verification of all required documents.

7. Scholarship Disbursement and Enrollment Procedure

The scholarship entitles the selected candidate to a partial exemption of 50% from the tuition fee of the Master's program. After receiving formal notification of the scholarship award, the candidate must:

- Confirm acceptance of the scholarship within 5 working days
- Complete enrollment in the Master's program within the same deadline

Failure to respect this deadline will result in automatic forfeiture of the scholarship, which will then be reassigned to the next eligible candidate.

7. Assessment of Economic Conditions

The Italian Institute of Fashion Management reserves the right to carry out random checks on the accuracy of the financial information and declarations submitted by applicants.

Applicants may be required to provide additional documentation supporting their declared economic condition. For Italian residents, this may include official tax forms such as Modello Unico, or similar.

Candidates are strongly encouraged to submit truthful and complete information. Any false declaration or omission may result in exclusion from the scholarship selection process or revocation of the scholarship if already awarded.
